The MNAS program will drop the GRE requirement for student admission. The MNAS committee and CNAS leaders including the Dean and departmental heads approved this admission requirement change. The key reasons for this action include 1) little correlation between GRE scores and success in graduate school, 2) because of a wave of graduate programs dropping the GRE requirement, and 3) to attract more student applicants to the MNAS program (domestic and international students).
